

RESOLUTION NO. 2023-02

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF LACROSSE, WASHINGTON, ADOPTION OF WATERWORKS AND SEWER, CEMETERY, BUILDING PERMIT, LABOR & EQUIPEMENT, AND A NON SUFFICANT CHECK FEES

BE IT HEREBY RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF LACROSSE, that this resolution is to be set forth those fees charged by the Town in one resolution for easy reference and amendment, and,

BE IT FUTHER RESOLVED, that any previous resolutions are hereby amended to reflect the fee changes made by this document.

THIS RESOLUTION SHALL BE IN EFFECT ON 9th DAY OF FEBRUARY 2023.

WATERWORKS ORDINANCE NO.347 07-2008 SECTION 5 & 23

Unauthorized turn on & shut off Fee \$ 50 for first offense and \$250 for each additional offense

A \$1.00 Fee will be charged to each Minimum charge: beginning each January for the next five years 2022-2026

Minimum charge of \$29.00/month for 400 cubic feet of water or less;

A charge of \$.35 per 100 cubic feet or fraction thereof for next 400 cubic feet:

A charge of \$.20 per 100 cubic feet or fraction thereof for all water consumed

Over and above the first 800 cubic feet per month.

RV Trailer Park (no permanent trailers) is billed one minimum meter \$29/month and usage:

A charge of \$.35 per 100 cubic feet or fraction thereof for next 400 cubic feet:

A charge of \$.20 per 100 cubic feet or fraction thereof for all water consumed

Over and above the first 800 cubic feet per month.

Bulk Water fee: \$15.00 per 1000 gallons.

Water Loan Fee: \$7.00/month thru Sept 2014 then add \$7.00 for a total of \$14.00/month thru Sept 2015 then add \$7.00 for a total of \$21.00/month thru Sept 2034 - the end of Water Improvement Loan.

Water Deposit: two months water and sewer and utility tax

After 07-10-08 All New Water to be billed to owner of the property only – NO New Renters will be billed.

Delinquent Water Turn ON fee\$20

Garden water shut OFF and ON fee\$0

Water shut OFF fee.....\$20

Open and Close Burial \$700.00
Weekend, ~~Holiday~~ & After Hours Closing \$ 850.00
Open and Close Cremation Burial or Headstone Interment \$ 250.00 *with exceptions.*
Weekend, ~~Holiday~~ & After Hours Cremation Burial or Headstone Interment \$300.00 *with exceptions.*
Additional \$25 per man hour for snow & ice removal when preparing for a burial or cremation burial.

LABOR & EQUIPMENT RATES:
Backhoe \$100 /hour includes one town employee to operate the machinery.
830 Tractor \$70/hour includes one town employee to operate the machinery.
Sewer Machine \$50 /hour plus TWO Town Employees Wages (L&I, Unemployment Insurance,
Retirement & possible Overtime)

BUILDING PERMIT VIOLATION FEE:
Failure to obtain and purchase a valid building permit before construction begins = STOP WORK
ORDER until a building permit application is approved by the building inspector and a **DOUBLE DOLLAR**
